GENERAL TERMS AND CONDITIONS FOR RESERVATION

Rental is individual and non-transferable. It cannot be given or sublet to a third party. The lessee and all co-tenants must adhere to the camping site's internal rules and regulations.

CAPACITY

Only 8 people (including young children) are accepted for a 8-person rental, 6 people (including young children) for a 6 person rental, 4 people (including young children) for a 4 person rental 2 people (including young children) are accepted for a 2-person rental and only one vehicle is permitted per space. The data provided by the lessee will be used as a basis for calculation. Any additional person within the limits of the selected accommodation capacity must be declared upon arrival and will be subject to a corresponding increase in price. In conclusion, any incorrect declaration or modification will lead to a change in the fee for the stay and, subsequently. The contract shall lapse except if an agreement is made with the manager. Any breach of contract by the lessee will lead to forfeit and payment to the manager of a fee worth 30% of the total for the stay. Moreover, we do not accept minors (less than 18 years of age) if they are not accompanied by their parents. Day visitors are required to pay "visitor's fee".

FEES

RESERVATION - MEANS OF PAYMENT

Attention, the bill will be emitted in the name given during the reservation.

The reservation will be effective upon the deposit of 30% of the rental total and receipt of the rental contract that must be correctly completed and signed (which indicates the acceptance of the clauses and provisions of the reservation general terms and conditions).

FACILITIES AND LEISURE

The camping site gates are open from 7 AM to 10 PM. The reception desk is open during the off-season period from 8AM to 12PM and from 2PM to 7PM from Monday to Saturday and on Sunday from 8 AM to 12 PM and from 3PM to 7 PM.

For July and August the reception desk is open from 8 AM to 1PM and from 2PM to 8PM.

During July and August, the following are open daily:

- Grocery shop/snack area
- Bar

DEPOSITS

The rental material undergoes a valued inventory. The lessee is responsible for verifying the material upon his arrival and alerting the reception desk of any anomaly before noon the following day. You will be required to make deposits of 400€ for the rental, and 60€ for gate pass on arrival. These deposits will not be cashed and will be returned after taking inventory when the lessee leaves with the amounts for noted damages and/or missing equipment deducted. 85€ for cleaning

ARRIVAL AT THE CAMPING SITE

All lessees must introduce themselves upon arrival to the camping site reception desk with their letter of confirmed reservation sent by the postal service to their address after payment of the stay.

Arriving after 8 PM during season or 7PM off season, please inform the camping site personnel.

The manager reserves the right to use the campsite if he has no news within 24 hours, after the planned arrival date. Once a stay has begun, the total price of the stay must be paid the camping site. No refund is possible for an early departure or late arrival under any circumstances.

ANIMALS

Animals are only authorized if monitored and on leashes. However category 1 dogs "attack dogs" (pit-bulls) and category 2 dogs "watchdog od defense dogs"(Rottweiler) as defined by French law are strictly forbidden. Photocopies of your dog or cat's vaccination papers and tattoo number must be presented upon your arrival. In order to respect everyone, we are committed to respecting living spaces (takes the necessary measures).

CANCELLATION GUARANTEE

To settle during your reservation

This option guarantees you the reimbursement of the sums paid ,4% of the amount of the stay (see contract condition) IF you wish to subscribe to the cancellation insurance , do not forget to check the box on the contract

Cancellation guarantee: Insurance GRITCHEN 4%-To be paid upon reservation.

This option guarantees you the refund of sums paid, except the cancellation guarantee itself, in the event of job loss, illness or severe accident, death of any person partaking in the stay prior to the beginning of the rental, written proof must be sent in a registered letter within 3 days. You would like to subscribe to the cancellation guarantee ,please do not forget to check the corresponding box in the contract.

NOTE:ACCOMODATION RENTAL space

Off-season: Per-night or weekly rentals can be made (arrival and departure days and times must be agreed upon with the reservation service.

Arrivals from 10am to 12pm and 2.30pm to 6pm.Departures until 2pm according to schedule.

During the season (July-August) ,rentals are done weekly from **Saturday to Saturday**, arrival from 3pm.Departure before 10am.

NOTE FOR CAMPING PLACE RENTALS

The camping site space rentals can be rented per-night or weekly. Arrival from 12pm.Departure before 12pm.

INSURANCE

Travel and resort civil liability are MANDATORY.

The signature of the contract means that the lessee has read and understood the present, that he accepts the terms as written without reservation and releases the right to any personal interpretation of said contract. Any dispute not resolved amicably will fall under the jurisdiction of the Dunkerque Courts.
